

# HEAVEN PREVIEW FOUNDATION

How much do you enjoy driving your Honda or Lamborghini? If an accident or only two or three authorized dealers per a degenerative disease would steal tomorrow your ability to fully use your arms and legs, would you still be able to drive yourself to your office or to the beach? Today's technology enables thousands of people to drive with adaptive equipment--at **staggering** costs very few can afford. The Autopilot Program of the Heaven Preview Foundation offers grants to disabled people for purchasing electronic driving systems and for covering the cost of the required driving training.

## A Car or a Space Shuttle

If you ever enter the vehicle of a disabled person, your first impression will be that you are on a NASA space shuttle ready to take off to the moon. The primary controls (steering, gas, and

brake) are activated with minimal muscular effort through a mini-wheel (W-



series), a lever (L-series), or with a joystick (J/Aevit 2.0 systems as shown in the picture on the right). The secondary controls, such as turning signals, P/R/D, and headlights, are simply icons on a touchpad screen of a computer. ### The Cost of Freedom

Only a few makes and models of vans and minivans lend themselves to adaptations for a disabled driver: Dodge, to afford even purchasing the vehicle in Ford, Chrysler, Honda, and Toyota. These vehicles are always factory special orders, and they come with a high price tag anywhere from \$50,000 to \$65,000. The next step is to install a \$30,000 lift or ramp in the vehicle through a specialized dealer. Then, with EMC as

the only manufacturer in the U.S. and state, the costs of purchasing and installing an electronic driving system in your vehicle range from \$45,000 to \$85,000. The more severe your disability is, the more you pay for your freedom!

A specialized rehabilitation trainer will charge anywhere from \$300 to \$650 per hour for 20 mandatory hours to evaluate your ability to drive with adaptive equipment. Without his/her signature, you cannot legally order and purchase your driving system. Another 60 hours of driving training with such an expert are then required in order to assess if the equipment has been properly installed and to teach you how to use it.

## The total cost of driving for a disabled person: somewhere around \$200.000!

## **Available Financial Assistance**

There are a few extraordinary people who cannot move their arms and legs enough to drive a regular car, but who can produce sufficient income to afford driving a fully adapted vehicle. But most do not!

The only two organizations in the U.S. that provide financial assistance for vehicle adaptations and driving training (but <u>not</u> to purchase the actual vehicle) are Vocational Rehabilitation (VR) and the Department of Veterans Affairs

(VA). VR requires that your gross annual income be under **\$14,000**, which would make it impossible for someone the first place. With both organizations, the paperwork will drag for months and the whole process may take even up to a year.

When it comes to assistive equipment, banks simply do not have that option to check on the loan applications. In the state of Georgia, for example, you can only get a Credit-Able loan through CFII (Center for Financial Independence and Innovation, Inc.) at an interest that promises to be low, but it is always higher than the average car loan interest. Moreover, even if this is advertized as a loan for the equipment, if you happen to have the vehicle already, they will turn you down stating that they provide a loan for vehicle and equipment together, so that they can hold your new vehicle as collateral.

## **Autopilot Grants**

The Heaven Preview Foundation understands that many disabled people cannot afford purchasing the vehicle they could drive, and for them, our Autopilot Program provides the **Shuttle Grant**. For those who already have a vehicle, we offer various **Pilot** Grants for purchasing the adaptive equipment and for paying the driving training.

### Turnaround Time

All applications for Autopilot grants are reviewed and processed within 30 days from receipt. Grant payments are made to dealers or trainers within 3 business days from approval or on any later date requested by the grantee.

### Amounts

Most Autopilot grants range from \$500 to **\$10,000**. However, we are making efforts to offer in the future full grants that would cover the entire cost of a vehicle, equipment, and training.

### Eligibility

Applicants for our **Autopilot** grants must present, along with their application, supporting documentation for the following: (1) a neuro-muscular or skeletal disability diagnosis; (2) the signed approval of a driving trainer (for

equipment grants); (3) a gross income ranging from \$0-\$100,000/year; (4) use of an authorized dealer and a certified driving training specialist; (5) residence in the U.S. (immigration status not required).
